



## Open Meetings Act

The Michigan Open Meetings Act ("OMA") is meant to enhance transparency, but it can create confusion for public bodies. Often we find that violations of the OMA are not intentional, but rather occur due to lack of knowledge about the law's requirements. - How much time must be reserved for public comment?
